Because we hold that American Home does not have statutory standing to sue in its own right, we do not address whether Aetna was acting in a fiduciary capacity when it allegedly breached its fiduciary duties to American Home in settling the case 7 Specifically, the court stated that: Aetna allowed the claim of the uninsured motorists to be tried to a jury and Aetna allowed the case to go to the jury with the expectation that the jury would find in favor of the uninsured motorists. When that occurred, Aetna was able to take the proceeds of the settlement and pay off its insureds. This can be seen as a complete net benefit to Aetna. Id. at 762. 8 Like the court in Dameron, we are "persuaded" by the outcome of this case and therefore choose to use this extraordinary language to express our concern over the artificiality of allowing an insurance company,

who never actually stood in the shoes of its insureds, to pursue a third-party claim as a plaintiff. In *Dameron*, this conclusion was driven by the court's recognition of the difficulty of calculating damages against the tortfeasor's insurer. See *id.* at 761-62. Here, however, the result we reach does not depend on the merits of the underlying claims against Aetna, and we are not therefore faced with this calculational challenge.⁹ Such a holding would be particularly inappropriate where, as here, Aetna's contribution claim against American Home would not be satisfied until after Pennsylvania state law would bar any recovery on the claim against the uninsured
