The petition to vacate the judgment was filed on the ground the original judgment was void as the judgment had not been rendered by the proper court and the plaintiff had never served an *466 answer within the time prescribed by section 580(2) of the Code of Civil Procedure. Respondent county did not controvert the allegations of appellants' petition, but entered a general demurrer thereto. The trial court sustained the demurrer without leave to amend, and entered its order dismissing the same from the files, and from which an appeal has been taken. [1] It is now well settled that a court of equity may vacate a void judgment either by vacating the judgment or the proceedings by which it was rendered. (27 Cal.Jur. 587, sec. 139; Andrews v.
